60/19 NOMINATION OF INCOMING MAYOR AND THE ACCEPTANCE OF OFFICE: TOWN CLERK

Cllr. Ryan will accept the office of Town Mayor that will be made to him by the Town Council.

Cllr. Ryan made his declaration of acceptance to the Town Clerk and the Town Council and was duly elected as Mayor of the Fishguard and Goodwick Town Council.

61/19 NOMINATION OF INCOMING DEPUTY MAYOR AND THE ACCEPTANCE OF OFFICE: TOWN CLERK

77/19 CONTINUING WITH THE TOWNS FREE WI-FI SCHEME: CLLR. RYAN

The costs for this scheme have been supported by PCC since it was introduced in 2016. As from 1.6.19, the Town Council agreed to take on the running costs for the next three years.

The costs were discussed.

The agreement is for a three year period with the following associated costs:

The costs are:

There are 12 access points.

£195 per access point, for 3 years = $12 \times 195 =$ £2,340 or

£100 per year, for 3 years at £100 per year = £1,200 or £3,600 (for the three years)

Maintenance £100 per access point, per year = £1,200 or £3,600 for 3 years

Splash (landing) page - £350 per system, per year.

For 3 years, the upfront costs would be: £6,990

Annually (but tied into a 3 year agreement) the upfront costs would be: £2,750

There was a healthy debate for and against the system.

Standing orders were dropped at 7:45pm to allow consultation with members of the public present. They were re-adopted again at 7:47pm

It was resolved to further investigate the costs and to see if comparative costs for the free WiFi system could be researched.

78/19 LETTER OF SUPPORT FOR SEA TRUSTS BID FOR GRANT FUNDING: CLLR. STOKES

Sea Trust are applying for grant funding and have asked the Town Council to support them by way of a letter, in their bid for this.

Does the Town Council agree?

It was resolved that the Clerk contacts Sea Trust to find out how much they are asking for and subject to them not asking for an extraordinary portion of the Enhancing Pembrokeshire Fund, the letter should be written.

The Clerk will ascertain details from PCC with regards to the amount available and will email all Cllrs. with the information before sending the letter.
